3. Subject Survey Reports have been under consideration by the Headquarters Board of Survey for some time and upon initial review, it was the opinion of the Board that all of the circumstances had not been completely brought out and that further investigation would be necessary to establish the facts. Since that time the file was referred to the Inspector General who subsequently advised that he had withdrawn his objection to and interest in the approval of these Survey Reports. At the Headquarters Board of Survey meeting of 24 February 1955 these Reports were again reviewed by the Board and based upon the fact that the Senior Representative has recommended a write-off approval; that the available evidence indicates that the climatic conditions and existing storage facilities were the primary causes of the deterioration and that there is no positive evidence of negligence on the part of Agency personnel, it is the

unanimous recommendation of the Board that all concerned be relieved of accountability and responsibility for the [redacted] and the stock records be adjusted accordingly.
