SUBJECT : Funds for JOT Program

1. This memorandum contains a recommendation submitted for DCI approval. Such recommendation is contained in paragraph 5.

2. Attached is a request for an increase in the allocation of funds for the Office of Training. This request is necessary because of the JOT Program which was approved at a ceiling of [redacted] positions by the DD/S in connection with the FY 1958 budget and provided funds for only [redacted] positions. At that time, the Office of Training was instructed to continue recruitment and also to study the problem of reducing the time individual JOT's spent in the program and on the JOT allotment.
