DESCRIPTION AND SCOPE OF PROJECT

OCDC requests allocation of funds in the amount of \$2,000 from the 1949 appropriations for a survey of commercial sources [redacted] for foreign photographs and the acquisition of certain photographs currently required for the Graphics Register. The sum involved would cover both the travel costs and procurement costs incurred prior to 30 June 1949. It is proposed to send the Chief of the Photographic Division, Graphics Register, to [redacted] to work with the [redacted] for the survey and procurement. In view of the fact that some commercial sources will involve security problems, it is requested that all procurement be authorized out of unvouchered funds which may be advanced as required. The survey will also be a basis for planning purchase of photographs in the future for MIS program and other intelligence activities and for photographs for the Graphics Register and files.
