DESCRIPTION AND SCOPE OF PROJECT

Funds were provided to OSO for the fiscal year 1949 for the support of the branch responsible for the control and expenditure of confidential funds. By [redacted] effective 1 January 1949, the Confidential Funds Branch was transferred from OSO and placed under the Budget Office, CIA. Certain expenses, not chargeable to specific covert projects or activities, will be incurred by the Confidential Funds Branch through 30 June 1949, and for these no provision has been made. Consequently, approval is requested of allocation of confidential funds for these purposes in the following amounts, to be deducted from the OSO allocations by bookkeeping transfers, or from OPC, if necessary.
