9. With reference to the NIS publications listed in 4, above, what are the major shortcomings you have found in the NIS? (Please relate these to your own needs, considering adequacy of coverage, reliability of content, currency, length and detail of presentation, and security classification.) The information provided on page 2 might appear to smack of redundancy and the expenditure of minimal efforts. However, this command is preparing contingency plans on selected countries and find the NIS publications invaluable. Frequently the information presented is extremely antiquated and only useful as corroborative information. This applies primarily to Coasts and Landing Beaches, Ports and Naval Facilities and Armed Forces which are subject to frequent changes.
