2. Career Training Program

The October class began on 3 October with an enrollment of 75. A total of 79 entered on duty for the class, including 63 externals and 16 internals. These, plus four hold-overs from the July class, made a total of 83. Of the 83, eight were enrolled in military programs before 3 October. Of the 75 currently enrolled, 9 will be withdrawn after the Intelligence Orientation phase (14 October) because of pending military assignments, leaving 66 to carry on.

6. Department of State vs. PPB

On 27 September [REDACTED] of our External Training Branch visited the FSI to review State's policies and procedures on external training. 7. EOD Training

Indications are that Agency components are giving maximum cooperation in enrolling people in the Intelligence Orientation Course. The Office of Communications is considering the exemption of certain categories of their employees, but so far almost 100 per cent of their EODs have been enrolled. In a few instances, NPIC and Security have requested certain of their EODs be deferred until later courses.

8. Indonesian Language Training

A request has been received from seven students to commence Indonesian language training in January. Four of these are officers and three are dependents. A second Indonesian language instructor has been cleared.
