REF: MEMO FROM CIA/TSCO TO AREA TSCO DATED 1 JULY 1966

1. PER YOUR REQUEST THE FOLLOWING COMMENTS ARE SUBMITTED FOR YOUR CONSIDERATION:

A. RE REFERENCES: IF THE AREA CONTROL OFFICERS AND CODEWORD CONTROL OFFICERS ARE TO EFFECTIVELY CARRY OUT THEIR RESPONSIBILITIES IT IS NECESSARY THAT ALL APPLICABLE REPORTS, CORRESPONDENCE, INSTRUCTIONS BE DISSEMINATED TO THEM FOR THEIR GUIDANCE AND SO THAT POLICIES AND PROCEDURES MAY BE IMPLEMENTED. TO THE BEST OF MY KNOWLEDGE THE REFERENCES REFERRED TO IN REFERENCE DOCUMENT WERE NOT RECEIVED BY THE TSCO AND TCO/NPIC.

B. RE FORM 2600: THIS IS NOT A PRACTICAL FORM FOR USE BY NPIC IN THAT INSUFFICIENT SPACE HAS BEEN ALLOWED FOR DOCUMENT IDENTIFICATION. WITH THE VOLUME OF DISSEMINATION HANDLED BY THIS CENTER IT WOULD BE IMPOSSIBLE TO PLACE A SINGLE DOCUMENT (THAT IS ALL THAT SPACE ALLOWS) IN SEPARATE DOUBLE WRAPPED EVELOPES AS WOULD BE NECESSITATED. THIS MAY BE APPLICABLE WHEN ONLY LIMITED DISTRIBUTION IS MADE.

2. ACCORDINGLY, REQUEST:

A. NPIC BE AUTHORIZED TO CONTINUE USING THE EXISTING PROCEDURES, AND

B. RECONSIDERATION BE GIVEN TO THE STRUCTURING OF THE FORM AND THE ADVISABILITY OF UTILIZING PRE-CARBONIZED PAPER.
