1. CAMERA B 7 WAS USED IN MISSION 3696 FLOWN ON 20 AUGUST 1963; PROCESSING WAS ACCOMPLISHED BY NAVY PIC.

2. ORIGINAL NEGATIVE:

A. THE EXPOSURE WAS ADEQUATE, THE RESOLUTION IS GOOD WHERE NOT EFFECTED BY ATMOSPHERIC CONDITIONS.

B. 9R SIDE: ON FRAME 48 THERE IS AN EMULSION LIFT.

C. 9L SIDE: MINUS DENSITY DOTS 1.55" APART AND 1.35" FROM

THE OUTBOARD EDGE ARE FOUND THROUGHOUT THE ENTIRE MISSION. IN ADDITION THERE IS AN UNUSUALLY LARGE NUMBER OF EMULSION LIFTS, PINHOLES, AND BLISTERS IN THIS SIDE. SOME OF THESE BLISTERS AND EMULSION LIFTS WERE SERIOUS ENOUGH TO CAUSE SMALL TEARS AS FOR EXAMPLE ON FRAMES 337, 338, 339, 452, 451, AND 1094. THE LESS SERIOUS EMULSION DEFECTS OCCUR TOO OFTEN TO BE ENUMERATED.

D. BOTH SIDES: THE METERING IS ALSO SLIGHTLY ERRATIC ON BOTH SIDES AND THERE ARE SLIGHT PROCESSING STREAKS THROUGHOUT. THE APPARENT RESOLUTION WAS DEGRADED DUE TO ADVERSE ATMOSPHERIC CONDITIONS.

E. EXCEPT FOR THOSE ENUMERATED ABOVE, THERE ARE NO MAJOR PROCESSING ANOMALIES OR CAMERA MALFUNCTIONS. TOTAL NUMBER OF FRAMES WAS 2,385.

3. POSITIVE:

A. PI SUITABILITY WAS GOOD.

B. CLOUDS OBSCURED ABOUT 65 PERCENT OF THE MISSION.
