AT THE REQUEST OF [] A SPECIAL RAPIDLY PRODUCED UNTITLED DUPLICATE OF MISSION 4035 WAS PRODUCED TO PROVIDE SPECIAL INFORMATION REQUIRED BY THE [] STAFF. THE FOLLOWING INFORMATION IS PROVIDED ACCORDINGLY:

A. CONSTRUCTION AT THE MOSKVA PROBABLE ABM FACILITIES (E05, E24, E31, E33 AND THE DOGHOUSE) OBSERVED ON THIS FAIR-TO-GOOD INTERPRETABLE PHOTOGRAPHY IS CONSIDERED TO BE AT A NORMAL PACE BASED ON OBSERVATION OF THESE FACILITIES OVER A FOUR YEAR PERIOD. SUCH CHANGES AS ARE OBSERVED DO NOT APPEAR TO REPRESENT ANY UNUSUAL DEGREE OF PROGRESS AT THE FACILITIES IN RECENT MONTHS.

B. PHOTOGRAPHY OF GOOD INTERPRETABILITY OF THE SARY SHAGAN MISSILE TEST CENTER, REVEALS THAT CONSTRUCTION CONTINUES ON GALOSH LAUNCH POSITION C-3. HOWEVER, NO NEW FACILITIES OR NEW CONSTRUCTION STARTS NOTED THROUGHOUT THE COMPLEX. THE CONSTRUCTION ACTIVITY AT C-3 IS A RESUMPTION OF "INCOMPLETE" CONSTRUCTION. IN BRIEF, THE LAUNCH POSITIONS ARE NOW BEING EMPLACED AT C-2 AND C-3 WERE BEGUN IN SUMMER 1962, AND REMAINED DORMANT UNTIL 1966 RESUMPTION OF ACTIVITY. THE TRIAD FACILITY AT COMPLEX B IS COMPLETE AND NO CHANGES HAVE OCCURRED SINCE MID-1966 WHEN THE LARGE CRANE WAS REPORTED REMOVED FROM ITS LOCATION BEHIND THE LARGE BUILDING.
