



THE FOLLOWING INFORMATION REPRESENTS: A PRELIMINARY ANALYSIS OF AERIAL PHOTOGRAPHY FROM MISSION 8111, 8 AUG 66. THE NUMBER AT THE RIGHT MARGIN OF THE HEADER LINE IS THE COMOR TARGET NUMBER.

INTERPRETABILITY OF THE PHOTOGRAPHY IS CATEGORIZED AS G (GOOD), F (FAIR), OR P (POOR). THE EXTENT OF TARGET COVERAGE IS DENOTED BY THE SYMBOLS T (TOTAL) OR PT (PARTIAL). THE MODE OF COVERAGE IS SIGNIFIED BY ST (STEREO), NS (NONSTEREO), OR PS (PARTIAL STEREO).

AAA DEFENSES ARE DIVIDED INTO THREE BASIC CATEGORIES.—
LIGHT (ZPU-2, ZPU-4, AND 37MM), MEDIUM (57MM AND 85MM), AND HEAVY
(100MM AND LARGER). WHERE SUCH A CATEGORY CANNOT BE DETERMINED,
THE SITE WILL BE LISTED AS AN AAA SITE AND THE NUMBER OF GUNS
INDICATED (EXAMPLE 6-GUN AAA SITE, OCCUPIED/UNOCCUPIED).




