1. Reference (a) was originally routed to the Chief/EPIC/SS/LB, who requested that the Assistant for Plans and Development, EPIC confirm the validity of the overrun cited in reference (a). Reference (b) was prepared in response to this request.

2. Since the signing of reference (b), a new question has arisen concerning the validity of this overrun. In the Report on Final Audit, Case No. C-293, Exhibit A, attached to reference (a), there is a heading, "Period Audited" under which occur the dates 31 January 1963 through 31 August 1963, followed by a reference to a footnote. All this seems to indicate that costs were incurred after the contracted performance period which ended on 21 July 1963. Further, a letter from  to the Contracting Officer,  dated 29 July 1963, regarding the subject contract, stated that submitted herewith was the final report which completed all performance under the subject task order. Our files contain nothing to indicate that we authorized work following the submission of the final report.

INTERNAL SECURITY - (S)

3. In order to resolve this matter it is requested that we be furnished with the information necessary to determine when the  overrun costs were incurred and that work was performed to incur these charges.

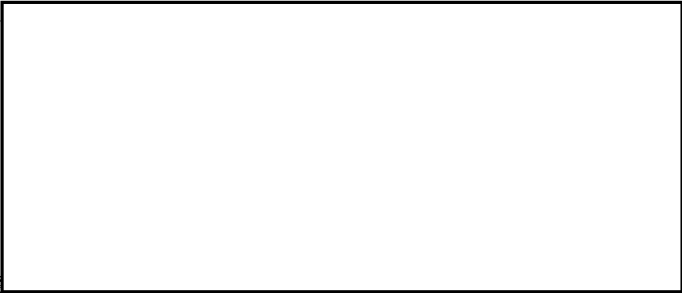

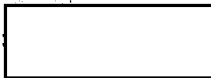
