(Confidential [redacted] LIAISON Met with Dorothy Fosdick, Permanent Subcommittee on Investigations, Senate Government Operations Committee, and provided her the 24 February 1973 memorandum which was the subject of [redacted] in the New York Times this morning. Fosdick was very upset that Senator Henry Jackson (D., Wash.) had not had prior notice of the release of the memorandum to the House Select Committee and I said it was our policy to assure that such not be printed but that the Select Committees have devoured vast quantities of data and this is one of those which was scooped up. She said that she requested for Senator Jackson that all similar matters involving him which have been transmitted to the Select Committees be forwarded to the Senator immediately. [redacted] Review Staff, has been advised.

10. (Unclassified [redacted] LIAISON Called Mike Kraft, in the office of Senator Clifford Case (R., N. J.), who said that the statement referred to by Senator Jacob Javits (R., N. Y.) was carried in the Trenton Times but that there must have been a misunderstanding by the reporter since Senator Case was directing the statement not at CIA but the Administration. We then had a rather lengthy conversation with Kraft indicating why he felt that the story on [redacted] had been leaked by Administration sources although he acknowledged that this would not excuse confirmation by anyone who participated in the briefing. STAT

11. (Unclassified [redacted] LIAISON In the absence of Marian Czarnecki, Chief of Staff, House International Relations Committee, advised Jack Brady, Staff Consultant, of briefings on [redacted] being scheduled for Representatives Larry Winn (R., Kans.) and John Buchanan (R., Ala.), which had been requested by John Holstein, of the Committee staff. STAT

12. (Unclassified [redacted] BRIEFING Called Guy McConnell, Senate Appropriations Committee staff, and confirmed the 9th and 10th of March 1976 for the Director to brief the Committee on the intelligence community and Agency budgets. STAT

I also advised Mr. McConnell that [redacted] who was referred to the Agency by McConnell, will be entering on duty on 10 May 1976 as [redacted] was very appreciative of this information. STAT

13. (Unclassified [redacted] LIAISON Received a call from Chuck Snodgrass House Appropriations Committee staff, who said Chairman George Mahon said he saw a newspaper article about an interview with John McCone and asked me for a copy of that article. I told him I didn't recall such an article, but there had been a full page in the Evening Star the other night in which the TV Guide article by Mr. McCone was reprinted. I said I would check further and be back in touch. Mr. Thucrmer's office advised this was the only article in recent weeks concerning Mr. McCone. Before I had a chance to call Snodgrass, he called me and said it was the TV Guide article and they did have a copy of that. He thanked me for checking on it. STAT

(Confidential [redacted] LIAISON Guy McConnell, Senate Appropriations Defense Subcommittee staff, called and said Chairman John McClellan (D., Ark.) wants to have the budget hearings the week of 8 March 1976. McConnell said the dates 9, 10, and 11 March are open. They want the Director to start the hearings with the intelligence community budget on the morning of the first day, followed that afternoon by Mr. Ellsworth (DOD). The following morning will be Mr. Plummer (DOD), followed in the afternoon by the Director with the Agency budget. McConnell asked that we decide which two consecutive days we want and let him know so they can firm up the schedule. [redacted] is checking Ambassador Bush's calendar and will let us know.
