9. (Unclassified - LLM) LIAISON Called Frank Slatinshek Chief Counsel, House Armed Services Committee, about the status of S. 3664. It was his understanding that further action on the bill had stopped but he said he would reconfirm in light of our information that the bill was scheduled for mark-up and possible floor action this weekend.

Later, Slatinshek called confirming that the bill is dead for this year but that the language of our amendment is acceptable and would be included in any new bill if it is considered in the next Congress.

✓ 6. (Internal Use Only - LLM) LIAISON Kempton Jenkins, Congressional Relations, Department of State, called on behalf of Assistant Secretary Arthur Hummel, Bureau of East Asian and Pacific Affairs, making the case that all Administration witnesses, including the Director, should appear together before the Subcommittee on Arms Control, International Organizations and Security Agreements, Senate Foreign Relations Committee, to assure that no one is blindsided. He conceded the possible problem of whipsawing. I explained that the problem had grown because not only State but the National Security Council and ACDA wanted in also. Jenkins was unaware that Fred Ikle, Director, ACDA, was scheduled to testify and that we had already provided the Director's prepared statement to State. I also said we were getting a little bit different reading from the staff than they had gotten on having witnesses sit in on the Director's briefing and that it is essential that any such arrangement be acceptable to Chairman Stuart Symington. We may be hearing further on this. Later, the Director informed me of a call he had received from Helmut Sonnenfeldt, Counselor of the Department of State, on the same subject.

7. (Confidential - THW) LIAISON Tom Graham, Deputy General Counsel, ACDA, called and said that Director Fred Ikle appreciated Director Bush's position with respect to his presence at the hearing before the Subcommittee on Arms Control, International Organizations, and Security Agreements, Senate Foreign Relations Committee, and as an alternative asked if one of his technicians could sit in on Director Bush's testimony to ensure that Director Ikle had an adequate rundown of the hearing. 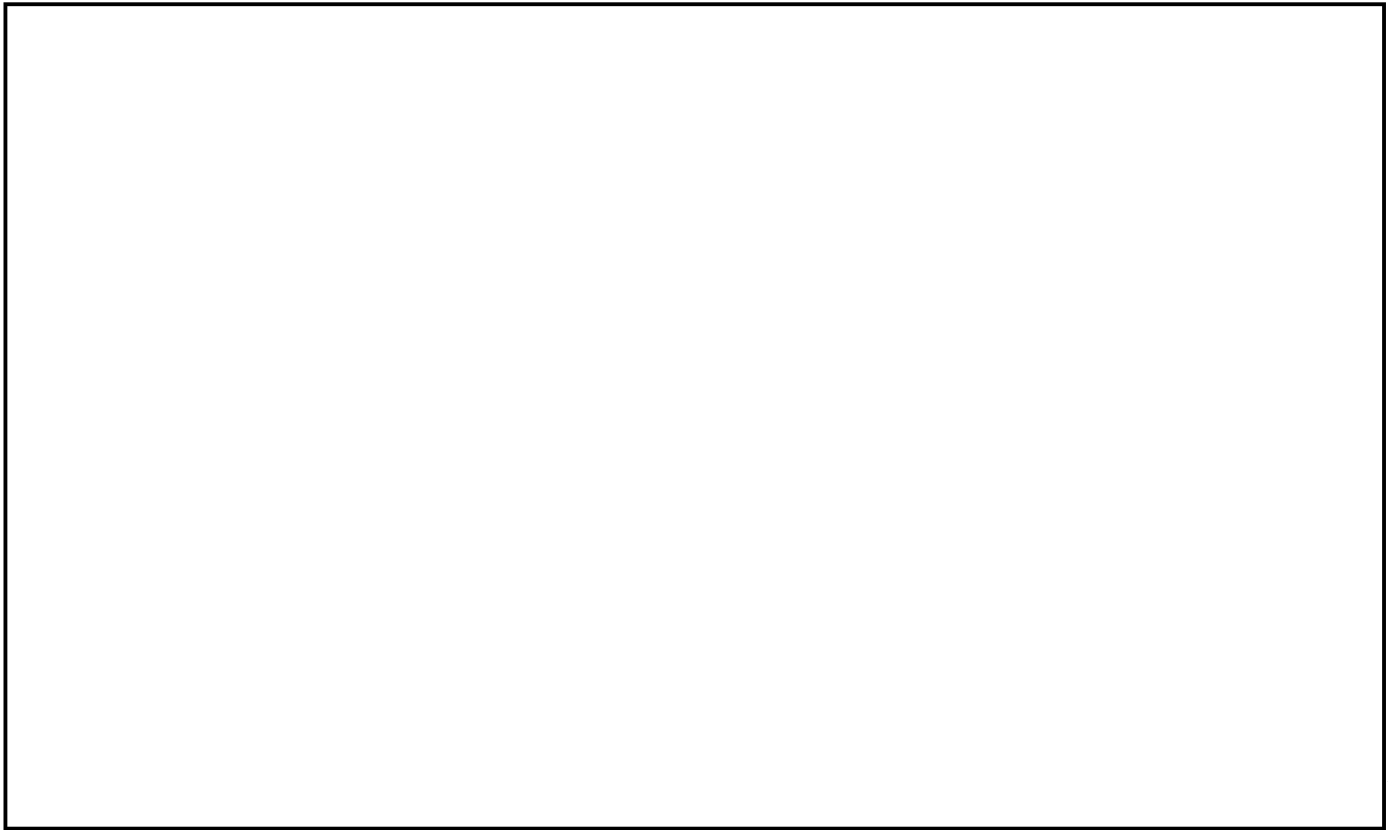

6. (Unclassified - SK) EMPLOYMENT At the request of Mrs. James, in the office of Representative Matthew Rinaldo (R., N. J.), I sent to her a one page brochure on the 1977 summer intern program for a constituent who is interested in learning more about the program.

7. (Unclassified - DFM) LIAISON Talked to Captain Vern Jennings, INR/State Department, regarding providing the Senate Select Committee on Intelligence access to the 1955 Clark Report and the 1974 Prince Associates Study of INR. The INR Report has been declassified and published, and Jennings gave me the title of the book.

8. (Unclassified - DFM) LIAISON Called Bill Miller, Staff Director, Senate Select Committee on Intelligence, regarding Agency briefings for the Committee. We established 23 September at 10:00 a.m. as a time for the briefing on budget matters and a long-term view of the Intelligence Community. Miller will get back to me with a firm date for the budget briefing.

9. (Internal Use Only - PLC) LEGISLATION Together with STAT  
  DD/P&S/OF,   DD/OP, and   ROB/STAT met with Bill Hogan, Counsel, House Armed Services Committee, and had a final discussion as to possible questions that might arise during floor debate on H. R. 13615, to amend CIARDS. We then stood by during the floor debate. The bill passed the House by a vote of 335-5.

10. (Unclassified - JK) LIAISON Met with Bill Miller, Staff Director, Senate Select Committee on Intelligence, to advise him of an intent to publish a Headquarters Notice on document destruction in the Federal Register. He concurred. Miller also stated that Senators Walter Huddleston (D., Ky.), and John L. McClellan (D., Ark.), would insert questions and answers on the appropriations conference in the Congressional Record during the Senate debate on the conference report.

Miller further stated that the SSC would be requesting a copy of the classified conference letter from Senator McClellan.

11. (Unclassified - JK) LIAISON Met with Chip Pickett, Senate Select Committee on Intelligence staff, to request again that he coordinate information requests and interview requests by the SSC Budget Subcommittee staff.

12. (Unclassified - RLB) LEGISLATION Discussed with Jim Davidson, Minority staff, Subcommittee on Intergovernmental Relations, Senate Government Operations Committee, and Lyle Morris, on the staff of Senator John Glenn (D., Ohio), certain problems with respect to S. 2925 (the zero-base budget review bill) which remained despite numerous changes to the bill. Further contacts will be necessary as the so-called sunset legislation is scheduled to come up for floor action later this month.

13. (Confidential - RLB) LEGISLATION Called Mr. Ronald Kienlen, Office of General Counsel, OMB, regarding the draft Executive Order on "Suitability Requirements for Government Employment," which the Agency now has for comments. I informed Mr. Kienlen the Agency and the Intelligence Community had extremely serious problems with the draft Order and will be getting our views to him as soon as possible. Mr. Kienlen said he would appreciate as much material as possible explaining our position but that his office hopes to avoid any delays in preparing a final Order for Presidential approval.

14. (Unclassified - TIW) LIAISON I talked to Philip Mayhew, Department of State, who returned my call to Ed Hurwitz, of the Korean Desk, Department of State, who had asked us to reconsider our position on not testifying before Chairman Donald M. Fraser's (D., Minn.) Subcommittee on International Organizations, House International Relations Committee, with respect to North Korea. I told him we did not feel we should change our previous position against testifying for various reasons which I discussed with him.

23. (Confidential - GLC) LIAISON Frank Slatinshek, Chief Counsel, House Armed Services Committee, called and said the CIARDS legislation would be called up on the floor on 10 September.

I discussed the letter which Representative Leonor Sullivan (D., Mo.) had written to Chairman Melvin Price, House Armed Services Committee, (which Chairman Price forwarded to us). I said our suggested response has gone to NSC, which got the original request. Slatinshek said there is a feeling among some members of Congress that the Administration is playing games -- deliberately downplaying evidence that there is some activity there which the members should be aware of so as to justify the giving away of the Panama Canal. He said he didn't know if this was true or not. He said we must be honest no matter what NSC says. I told him there was no question that we would give an honest reply.

Slatinshek also said there is quite a bit of interest in Soviet nuclear capabilities. There is concern on the Hill that they are not being kept informed of Soviet testing, that they hear practically nothing from the Executive Branch on any of this and they wonder why. He said he is directing this question to us and would like something from us as to the number of these tests in recent weeks [redacted]. I told [redacted] 25X1 we would get him a paper on this. [redacted] OCI, has been advised a 25X1 [redacted] provided a paper to Slatinshek.

24. (Confidential - GLC) LIAISON Mr. Herwitz, Country Director for Korea, Department of State, called and said he understood we had turned down a request to appear before Representative Donald Fraser's (D., Minn.) Subcommittee on International Organizations of the House International Relations Committee on the subject of human rights in North Korea. Herwitz wanted to know if we would reconsider. I told him the Director didn't feel there was anything we could add to what the Department has on the subject and it was better for State to handle it than us. He said the Agency does know quite a bit on other aspects such as economics, etc. I said I would look into this and get back in touch. [redacted] will handle. 25X1
