DURING FUTURE US NEGOTIATIONS WITH THE SOVIETS ON MOST-FAVORED-NATION TREATMENT, EC COMMISSION OFFICIALS WANT THE US TO RAISE SEVERAL DEVELOPMENTS THAT THE COMMUNITY FEELS COULD HURT US TRADE AND UNDERMINE GATT.

THE COMMISSION IS CONCERNED ABOUT THE NEW CZECH-FINNISH FREE TRADE AGREEMENT AND CONTINUING SOVIET PRESSURES ON FINLAND FOR TRADE CONCESSIONS. IF GATT SHOULD APPROVE THE CZECH-FINNISH AGREEMENT, THE COMMISSION IS WORRIED THAT THE CZECHS--AND PRESUMABLY OTHER EAST EUROPEANS--WILL BE COMING TO THE EC TO SUGGEST
