THE BANGLADESH GOVERNMENT DECREED A STATE OF EMERGENCY TODAY
 AND SUSPENDED SOME CIVIL LIBERTIES. A STATE OF EMERGENCY,
 ACCORDING TO THE DECREE, WAS REQUIRED BECAUSE "THE SECURITY
 AND ECONOMIC STABILITY OF BANGLADESH ARE THREATENED BY INTERNAL
 DISTURBANCES."

THERE ARE NO REPORTS OF NEW DEVELOPMENTS OR INCIDENTS THAT
 MIGHT HAVE TRIGGERED THE GOVERNMENT'S ACTION. FOR SEVERAL MONTHS,
 HOWEVER, PRIME MINISTER SHEIKH HASINA WAS BEING CONSIDERING WAYS
 TO INCREASE HIS GOVERNMENT'S POWERS TO DEAL WITH THE COUNTRY'S
 SEVERE ECONOMIC PROBLEMS AND ONGOING POLITICAL VIOLENCE. E-21705E
