25X1A [REDACTED] THAT EGYPT WOULD NOT OPPOSE A UNILATERAL SAUDI DECISION TO LIFT THE OIL EMBARGO AND RESUME FULL PRODUCTION (PRESUMABLY AT THE SEPTEMBER 1973 LEVEL).

25X1X [REDACTED] THE SAUDIS HAD NOT DECIDED WHAT, IF ANY, ACTION TO TAKE IN RESPONSE TO THE EGYPTIAN MESSAGE. [REDACTED] 25X1A

25X1A [REDACTED] THEY REPORTEDLY CAUTIONED CAIRO ABOUT A PREMATURE ACCEPTANCE OF AN ISRAELI DISENGAGEMENT PLAN. THE SAUDIS ARE STAD TO FEAR THAT DISENGAGEMENT ON THE SUEZ FRONT WILL NOT BE FOLLOWED BY A FULL ISRAELI WITHDRAWAL TO THE PRE-1967 BOUNDARIES.

THE SAUDIS ARE NOT INCLINED TO LIFT THE EMBARGO. [REDACTED] THEY WILL HAVE TO KEEP UP THE PRESSURE ON THE US TO SECURE AN ISRAELI WITHDRAWAL. THIS IS AT ODDS WITH [REDACTED] INDICATING THAT FAYDAL'S POSITION HAS RELAXED SOMEWHAT, AND THAT HE IS WILLING TO LIFT THE EMBARGO WHEN DISENGAGEMENT BEGINS--OR WHEN SADAT GIVES HIS GO-AHEAD--WITHOUT FIRST REQUIRING AN ISRAELI COMMITMENT TO COMPLETE WITHDRAWAL. ON BALANCE, WE THINK FAYSAL MIGHT BE WILLING TO END THE EMBARGO IN CONJUNCTION WITH DISENGAGEMENT, BUT WILL CONTINUE TO MANIPULATE PRODUCTION LEVELS UNLESS THERE IS AN OVERALL ARAB-ISRAELI SETTLEMENT THAT HE CONSIDERS SATISFACTORY.
