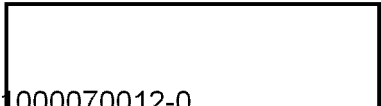

AREA IS POSSIBLY REVETTED AND CONTAINS 12 UNIDENTIFIED STRUCTURES/PIECES OF EQUIPMENT. THERE ARE 3 REVETTED MISSILE-HOLD POSITIONS WITH AN UNIDENTIFIED STRUCTURE IN EACH AND 5 OTHER POSSIBLE REVETTED POSITIONS. TWO MISSILE TRANSPORTERS ARE OBSERVED IN THE SITE AREA. A SITE SUPPORT, 1,000 FT NE OF THE LAUNCH AREA, CONTAINS 3 LARGE BUILDINGS AND SEVERAL SMALLER BUILDINGS.

AT THE ASWAN SAM SUPPORT FACILITY ARE 6 MISSILE TRANSPORTERS AND 6 PROBABLE VEHICLES/PIECES OF EQUIPMENT.

ASWAN SAM SITE B33-2 (FORMERLY A34-2) IS POSSIBLY STILL UNDER CONSTRUCTION. REDESIGNATION OF THE SITE WAS DUE TO A MORE ACCURATE LOCATION OF THE SITE AT 24-15-00N 032-46-30E APPROXIMATELY 12 NM NW OF ASWAN. THE SITE CONTAINS 6 REVETTED LAUNCH POSITIONS, A CENTRAL GUIDANCE AREA, AND ONE REVETTED MISSILE HOLD POSITION--TH OCCUPANCY OF ALL IS UNDETERMINED. NEAR THE SITE ARE 4 POSSIBLE VEHICLES/PIECES OF EQUIPMENT. A SITE SUPPORT, 2,000 FT SOUTH, IS IN LATE STAGES OF CONSTRUCTION. AN ALTERNATE SITE IS LOCATED 3,500 FT WEST OF THE MAIN LAUNCH SITE, AND A NEWLY IDENTIFIED SECOND ALTERNATE SITE IS LOCATED 3,500 FT WNW OF THE MAIN LAUNCH SITE.

THE NEWLY IDENTIFIED ASWAN SAM SITE CONTAINS 6 UNOCCUPIED REVETTED LAUNCH POSITIONS, AND AN UNOCCUPIED REVETTED CENTRAL GUIDANCE AREA. A SITE SUPPORT IS UNDER CONSTRUCTION 500-600 FT NW OF THE LAUNCH SITE.

THIS BRINGS THE TOTAL NUMBER OF KNOWN SA-2 SAM SITES IN EGYPT TO 23.
