10. There were no nominees from ORD for the Program for Management Development, Harvard University Business School.

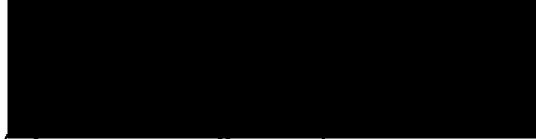

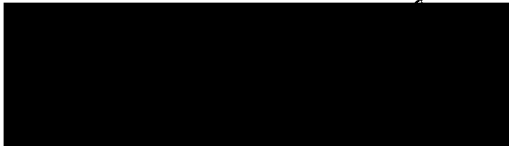
