We have received a request from Mr. T. Kelly Janes of the U. S. Environmental Protection Agency to arrange a one day visit to the Westinghouse R and D Center in Churchill Borough, Pennsylvania (near Pittsburgh) and to the Waltz Mill Coal Gasification PDU (Pilot Demonstration Unit), for a group of Russian technologists who will be visiting in the Pittsburgh area during the period 30 November to 5 December 1974.

The purpose of this visit would be to exchange technical information of a non-proprietary nature and to discuss the possibility of long range cooperative programs in areas of mutual interest. Subjects to be discussed are: coal and oil gasification, hot fuel gas cleaning, and combined cycle power generation.
