1. DEPARTMENT REQUESTED PASS INFORMATION BELOW TO DR. SIDNEY GALLER, DEPUTY ASSISTANT SECRETARY FOR ENVIRONMENTAL AFFAIRS.
2. SAWDOWSKI REPORTS THAT SOVIET SIDE WISHES TO ADHERE TO ORIGINAL VISIT SCHEDULE (JULY 29-AUGUST 11).
3. PLEASE ADVISE EMBASSY OF PRECISE ITINERARY FOR SOVIET DELEGATION IN ORDER THAT DELEGATION CAN ARRANGE AIR TRAVEL ACCORDINGLY.
4. DELEGATION PLANNING TO ARRIVE NEW YORK JULY 28 VIA AERO-FLOT FLIGHT FROM MOSCOW AND REQUESTS THAT SOMEONE FROM US SIDE MEET UPON ARRIVAL.
5. PLEASE NOTIFY DR. ROBERTS, DIRECTOR OF NBS, THAT MR. KOROBOV, DIRECTOR OF VNIIFTRI, WHO HOSTED HIM IN MOSCOW IN OCTOBER 1973 WILL BE A MEMBER OF THE SOVIET DELEGATION.
6. OPTION TWO ON JULY 31 PREFERABLE, STOESSEL
