1. SIGNIFICANCE:

THIS BRIEFING BOARD DEPICTS A TRANSSHIPMENT NET IN THE VICINITY OF THE VINH RAILROAD CLASSIFICATION YARD, NW [REDACTED] CONSISTING OF TWO RAIL-TO-ROAD TRANSSHIPMENT/STORAGE AREAS, A ROAD-TO-WATER TRANSSHIPMENT AREA AND A NAVIGATIONAL LOCK. 25X1

2. MISSION READOUT:

[REDACTED] REVEALS A RAIL-TO-ROAD TRANSSHIPMENT POINT WITHIN THE VINH RAILROAD CLASSIFICATION YARD, NW AT 18-41-00N 105-40-05E (UTM WF705660). TWO TRACKS OF THE RAIL YARD ARE SERVICEABLE AND A VEHICULAR CIRCLE IS OBSERVED ADJACENT TO THE RAIL YARD. FOUR PIECES OF ROLLING STOCK ARE LOCATED WITHIN THE RAIL YARD AND AN ADDITIONAL TWENTY-TWO PIECES ARE LOCATED SOUTH OF THE RAIL YARD IN THE VICINITY OF UTM WF702648.

A NEWLY OBSERVED RAIL-TO-ROAD TRANSSHIPMENT/STORAGE AREA IS LOCATED AT 18-40-57N 105-39-53E (UTM WF701656) WHERE A RAIL SPUR EXTENDS SOUTHWEST OF THE MAIN RAIL LINE IMMEDIATELY SOUTH OF THE RAIL YARD. THE SPUR BRANCHES INTO THREE SHORT SPURS IN THE VICINITY OF A DESTROYED/DISMANTLED ARMY BARRACKS AREA. STACKS OF PROBABLE SUPPLIES ARE OBSERVED ON TWO OF THE REMAINING BUILDING FOUNDATIONS. SIXTEEN PIECES OF ROLLING STOCK ARE ALSO OBSERVED IN THE AREA WHICH IS SERVED BY A WELL USED ROAD NETWORK.

THE VINH TRANSSHIPMENT POINT SONG VINH/HOANG MAI [REDACTED] IS OBSERVED SOUTH OF VINH COMPLEX AT 18-39-42N 105-40-20E (UTM WF709633). THIS ROAD-TO-WATER 25X1

TRANSSHIPMENT AREA CONSISTS OF SEVEN TRANSFER POINTS BETWEEN A PARALLEL ROAD AND THE KENH GAI (CANAL). AT LEAST TWO OF THESE TRANSFER POINTS HAVE PROBABLE SUPPLIES STACKED ADJACENT TO THE CANAL BANK. NUMEROUS RIVER CRAFT ARE OBSERVED DOCKED IN THE AREA. A WELL USED ROAD NETWORK CONNECTS THIS TRANSSHIPMENT POINT TO THE VINH RAILROAD CLASSIFICATION YARD, NW AND TO THE NEWLY IDENTIFIED RAIL-TO-ROAD TRANSSHIPMENT/STORAGE AREA.

ALSO OBSERVED IS A LOCK AT UTM WF741610 WHICH REGULATES THE WATER LEVEL OF THE CANAL.
