25X1A9a Discussed IN 16046 at some length with DD/I, ██████████
As a result of this discussion, it was decided that ██████████ and the O/SI man ██████████
25X1A9a who was planning to accompany ██████████ on ██████████ could go to ██████████ 25X1A
around the 1st of the year to exploit the individuals mentioned in the cable.
25X1A9a This is now to be discussed by ██████████ with DD/P people and I find that ██████████ 1A9a
25X1A9a is the individual with whom ██████████ should talk. I checked with ██████████ and so 25X1A9a
25X1A9a formed ██████████. Until these talks have been held and until the State Department
receives an answer to a cable they are sending out today, no decision can be
made here.

██████████ called back later to say that this matter was discussed at the DD/P
Staff Meeting this morning and that ██████████ will be calling the DD/I la ██████████ 25X1A9a
in the day to raise the fear that if CIA representatives become involved in
this debriefing operation, CIA may well find itself with the job of settling
hundreds and maybe thousands of emigres. ██████████ wished to make it very clear 25X1A9a
25X1A that as ██████████ will be provided for the Agency representatives,
and as up to this time CIA has never become involved in settling such people,
25X1A9a ██████████ feels that this fear is unfounded.
