Special Report of the HES Committee dated 16 January 1951.

- 1. There is forwarded heretith the "Special Report of the MIS Committee" pursuant to the request of the Committee that it be laid before the Director of Committee Intelligence for consideration by the Intelligence Advisory Committee.
- 2. Reference report sets forth proposals of the MIS Committee which would involve increasing MIS production to the equivalent of 12 MIS a year for fiscal year 1952, and to the equivalent of 15 MIS a year for fiscal years 1953-195h, in order to complete end to place fully on a maintenance basis MIS on all JCS high priority areas by 30 June 195h. General estimates of the necessary departmental capabilities to meet this proposed production goal are being prepared by the members of the MIS Committee for their respective Directors of Intelligence. Since the MIS Committee's proposals would also require increased support by the CIA in funds and services, there follows a general estimate of requirements affecting this Agency.
- 3. The services which the CIA directly provides for the NIS Program
 - a. The Basic Intelligence Division, O/SR, which performs the over-all coordination for the HTS Program and provides facilities for review, editing, and publication of the National Intelligence Surveys.
 - b. The Congraphic Division, O/RE, which is responsible for the preparation of the NIS maps and serves as coordinator and partial producer of Chapter II (Map and Chart Appraisal) of the NES.

- c. The Office of Special Operations, which has the production responsibilities for Section 56 (Intelligence and Security) of the NIS.
- d. The Office of Scientific Intelligence, which serves as ecordinator and partial producer of Chapter VII (Scientific) of the NDS.
- e. The Office of Collection and Dissemination, which prepares the original MIS Caretteer cheets by INM process, and is charged with the responsibility for the dissemination of the published MIS.
- k. Other agencies which receive CTA fiscal support for the HES Program
 - a. The Special Services Unit of the Covernment Trinting Office for the printing of MIS and Quaetteers.
 - b. The staff of the U.S. Board on Congraphic Marks for the development of NIS standard geographic names and for the geographic name additing of NIS material.
 - c. The Intelligence Agency of the Pepartment of State for the principal production of NTE Chapter IV (Sociological), Chapter V (Solitical), and Chapter VI (Reencode).
 - d. The Department of Agriculture (Office of Foreign Agrienliural Relations and Forest Service) for the principal production of NIS Section 61 (Food and Agriculture).
 - e. The Department of the Interior (Eureau of Sines and Fish and Wildlife Service) for the partial production of HIS Section 61 (Food and Agriculture), and for the principal production of HIS Section 62 (Fuels and Power), Section 63 (Hinerals and Metals), and Supplement V (Petroleum).
- 5. The additional support in services and funds which the GIA would be required to furnish under the proposals of the HIS Constitute cannot be fully determined until the various contributing agencies have indicated their requirements. This matter will be taken in hand as seen as policy determinations have been made. In general terms, however, it is estimated that for fiscal year 1952 the GIA services would need to be increased about 10%, and the GIA fiscal support to other agencies about 10%, over present considerate. There would probably be required an additional 15% increase in both services and fiscal support by the GIA for fincal years 1953-1956.

- 6. There is a severe shortege of personnel in the Covernment qualified to do intelligence work. This makes it urgent that the priority to be attached to an accelerated MIS program relative to other work for which such personnel is needed be carefully considered.
- 7. Attention might be given to the possibility of having some parts of the Surveys done by contractual arrangements with Universities or other private research groups. Such a procedure would not resove the necessity for a priority determination however, since such private groups can also be employed on other urgent research for the Covernment, and constitute one of the principal remaining pools of people from which requirement of intelligence personnel can be made.
