MEMORANDUM FOR THE DIRECTOR, NATIONAL RECONNAISSANCE OFFICE

SUBJECT : USIB Guidance on U-2 Coverage of the Far East

1. At its 26 February meeting the United States Intelligence Board (USIB), with the Director, National Reconnaissance Office present, considered the Committee on Overhead Reconnaissance (COMOR) memorandum in reference a., and as recorded in reference b., took the following actions on this matter:

"4. . . .

"a. Agreed that COMOR should review Sino-Indian border targets and develop for USIB consideration a list showing recommended priority of coverage.

"b. Amended and approved paragraphs 2 and 3 of the attachment to reference b. to read as follows:

'2. In terms of the program, therefore, and the timing therein recommended, as well as current examination by COMOR of the reconnaissance as soon as possible:

- 'a. South China (including Hainan Island)
- b. North Vietnam-Laos
- c. Sino-Indian border
- d. The Shanghai-Wuhu area
- e. Missile test range head at Shuang Cheng Tsu
- f. Manchuria
- g. North Korea
- h. Peiping
- i. Chih Chin Shia (Yumen)

'3. It is recommended that the Board request NRO to use its current authorization for four China missions, one North Korea and two North Vietnam-Laos missions, to cover these areas as rapidly as operational conditions permit, with emphasis on South China (including Hainan Island) and North Vietnam-Laos. "'

2. In accordance with the USIB action reflected above, a copy of reference b. is transmitted herewith as USIB guidance on this subject.
