1. In response to the request of the Executive Secretary, USIB (reference a), the Committee on Overhead Reconnaissance (COMOR) has reviewed Dr. Flax's 14 September memorandum reporting that the National Reconnaissance Office (NRO) has undertaken [Redacted] for OXCART.
