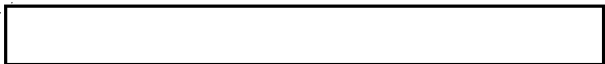

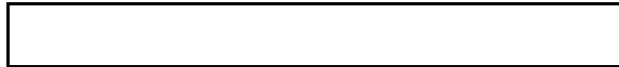

MEMORANDUM FOR: Mr. Bush

This is the report Mr. Colby provided to the President in Vail a year ago, two days after the Seymour Hersh article in the New York Times.

It was provided to the President in unclassified form in the event a decision were made by him to release it.

The President decided instead to consider it privileged and sensitive, and it became the first of the materials provided to the Rockefeller Commission when it was established to begin its investigation.

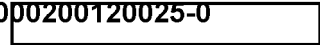
