Dear Mr. Bush:

Enclosed is a copy of the AIM Report for October. The entire issue is devoted to Victor Lasky's devastating critique of the Woodward and Bernstein book, The Final Days. I think you will find it of interest.

Accuracy in Media (AIM) has been engaging in combat with inaccurate and biased journalists for the past seven years. We have taken on Woodward and Bernstein previously for their failure to report on the prior knowledge of the Watergate break-in by high officials of the Democratic National Committee and columnist Jack Anderson. We finally got that story into the Washington Post by buying a full page ad to tell it in all its intriguing detail.

In recent months the AIM Report has exposed the New York Times for publication of an article slanted to favor the communist regime in Vietnam under a false name, with no indication that the identity of the author was being concealed. We revealed the author to be an official of the U. N. in Vietnam.

We showed how our tax-supported public television system aired a program on migrant farm workers in Florida that was a propaganda pitch for Cesar Chavez and his United Farm Workers Union. It was actually produced by people active in the Chavez movement!

We have shown how CBS has distorted the facts in an effort to persuade the public that industry is largely to blame for cancer. We have taken apart two CBS "documentaries" on the subject of chemicals and cancer.

We showed how the Eastern media downplayed revelations by the Los Angeles Times about campaign expenditures by the Carter campaign that violated the new federal election campaign laws.

You have probably heard about the great work AIM is doing. Why not join us? Contributions to AIM are tax-deductible.

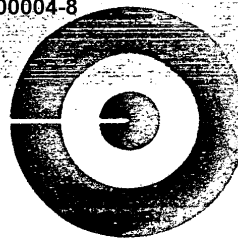

THE WOODSTEIN RIPOFF

The fact is that the principals described in this book, the sources of information for this book, and those who are making comments about this book all know the accuracy of this account. We stand behind every word of it.

The book, of course, is *The Final Days*, an account purporting to describe in detail what went on in the White House during the fifteen months prior to Richard Nixon's resignation as President of the United States.

According to co-author Woodward, the book "is an accurate account and will stand the test of time."

But, according to John Osborne, "it is on the whole the worst job of nationally noted reporting that I've observed during forty-nine years in the business."

Osborne, who has been "watching" the White House for *The New Republic* for many years, also took issue with the methodology used in obtaining material for the Woodstein tome.

"In this book," wrote Osborne, "they profess to report only what they've been told by 'at least two people.' That is crap . . . Some of the best stories I've ever gotten were known to one person only, the person who told me. Woodstein must know it's crap. The fact that they persist in the fiction in this book is a sign of insecurity . . ."

Also "crap" is Woodstein's repeated contention that, except for *pro forma* denials, no one has ever seriously disputed anything reported in *The Final Days*. This just isn't true. For, as we shall see, numerous individuals have ques-

tioned the accuracy of events described by the authors who keep claiming that they checked everything out with at least two sources. And a number of these individuals have said they were never even interviewed by the "dogged duo," as Woodward and Bernstein have been described in *The New York Times*.

Reading Finch's Mind

A case in point is the page-long description (pp. 255-256) of Robert Finch's visit to San Clemente at the height of the impeachment proceedings. Finch, of course, is an old friend of the President and a former Secretary of Health, Education and Welfare. As Woodstein described the meeting:

Finch thought that Nixon looked very tired. The President seemed fatalistic about his prospects; there was no hint of what he might do to avoid impeachment. The country had become so consumed by Watergate, Nixon said, that foreign affairs and the economy were being neglected. He could not just abdicate his position of leadership—resign in the face of the unstable world situation.

Finch was struck by the force of the President's words, the conviction behind them. He had arrived thinking that perhaps Nixon wanted to ask him to come back to Washington to help with the defense. But that was not the purpose of the invitation, though Finch was not

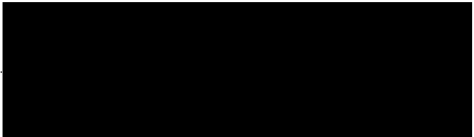

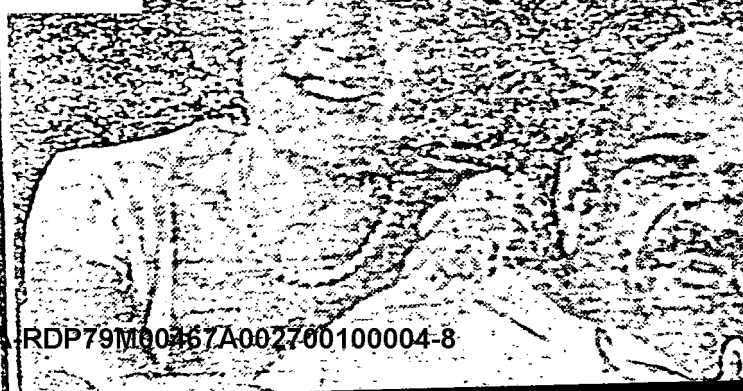
