SUBJECT : Nominations for Senior Seminar Six

1. The total number of nominations from the four Directorates and the DCI Area for CIA Senior Seminar Five which ran this past spring was only 22. As the Senior Seminar has space for 20 class members, the work of the Training Selection Board in considering nominees for Seminar Five was largely fruitless and it was not able to select a well-balanced class in terms of representation from all parts of the Agency, geographic area, knowledge and other criteria.

2. In order to attain the high level of participation in the Seminar which the Director has called for on several occasions, I would like to request each Deputy Director to nominate at least eight candidates (and three from DCI Area) for Senior Seminar Six which begins on 22 September and ends on 27 November 1974. Nominations of supergrade personnel or GS-15's with the potential of promotion to supergrade rank should be submitted to the Executive Secretary, Training Selection Board by 15 July 1974. Please submit six copies of all nomination papers--nominating statement, up-to-date biographic profile, badge picture, and the two most recent fitness reports. This advances the date for nominations but should enable the Board to ensure the selection of a qualified and balanced class for Senior Seminar Six.
