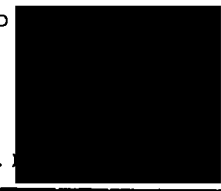

The Office of Naval Intelligence furnished the following information to CIA for IAC dissemination in accordance with paragraph 3c of NSCID #7. This information was obtained by DIO-3ND and was forwarded as ONI report 101-C-53.

- Charter and Cargo Information:** The Icelandic m/v Godafoss, owned by H/f Fimskipafelag Islands, Reykjavik, made a voyage to Gdynia, Poland, in February, 1953; she arrived in ballast on 6 February, and departed 8 February carrying general cargo, as follows:

- 650 pairs of rubber boots (Shippers: "Virimex" Pthz, Warszawa)
- 5000 jute bags, rye meal type, 2/80/E (Shippers: "Roline X", Warszawa)
- 25 cases of household articles (Shippers: CHEZ - Warszawa "Paged")

- 1 bale linen piece goods) Shippers: "Cetebe" Lodz
- 3 cases Chequer taffeta)
- 40 bales flax tow water retted)
- 51 cases household glassware)
- 150 cases window glass)
- 21 cases porcelit) Shippers: C Hartwig SA, Gdynia
- 60 bundles galvanized buckets)
- 44 reels newsprint paper)
- 10 bales pure parchment paper)

This cargo was delivered to various consignees at Reykjavik; the voyage was made for owners account.
