- I remember the following people in the City Central People's Board: Miculae Doncea, a General in the RPR Armed Forces, is the President of the Bucharest City Central People's Board.

(fnu) Levi is Director of the Commerce Section of the Bucharest City Central People's Board. He is 45 years old, medium height, blue eyes, bald, of Jewish origin, comes from Bacau (Moldavia region), member of the PMR Party. By profession he was, formerly, an ambulant street seller. He is hated by all the remaining private shop owners.

- "MAI (Ministry for Internal Affairs) and Militia. For organization of MAI, see Enclosure B/. During the fall of 1953, the Wilson Building was evacuated and reoccupied by the newly established Directia Metroului Bucuresti (Bucharest City Underground Directorate). The project of this underground failed, however, and the offices were closed. The building was then occupied by the MAI. (The DCM, General Directorate of the Wilitia, occupies two buildings on Victoriei Street: the Cretulescu Building which is in line with the former Royal Palace, now the Republic's Palace - near the Cretulescu Orthodox Church - , and the Dragomir Miculescu Building, formerly the Dragomir Niculescu Food Commodities Shop, which is now calthe Romarta Store / sic /). The entire area around the Republic's Palace is the fortress of the Communist Government. On Butching street are: the MAT Ministry, the Wilson Building, another unknown Directorate of the MAI Ministry, and the MSS Ministry (located on N. Balcescu Boulevard - formerly Bratianu Boulevard). The last occupies the former Ministry of Air space.
- "Nowadays pedestrians and vehicles are permitted free access to Boteanu Street. This was not permitted in 1952 and the spring of 1953.
- "The main DGCS (Directia Generala Comtrolul Strainilor Gemeral Directorate for the Control of Foreigners) Office, located in the Prefecture Palace (formerly the Profectura Politici) on Victoriai Street, together with the CMOB (Comand Amentul Vilitiei Orașului Bucuresti - Headquarters of the Militia of Bucharest) Office, supervises the DGCS Office on Nicolae Filipescu Street. I am certain of this, because when I departed from the RPR and went to pick up my visa and passport from the DGCS located on Nicolse Filipescu Street, that office had to send to the DCCS Office in the Prefecture Palace for my case file. Normally, no foreigner has enything to do with the DGCS on Nicolae Filipescu Street, or with the one in the Prefecture Palace. All formalities are taken care of by the City Sector Circa Militie Office for the Control of Foreigners.
- "The Circa de Militie P.O. (Guard and Order Militia): this organization, located on Spialul Unirel Street, between lanaries and Sulter Streets, had various sections / indicated on Enclosure B /, the P.O. sub-section dealing with order, the judiciary one with thefts, etc. The Militia Office personnel, including the chiefs of the various sub-sections, numbered approximately 12 - 14 persons, all of whom belonged to the MAI. Some of them were uniformed, others wore their civilian clothes. There were some women in the Militia; some of these wore uniforms. Normally a Captain, a II-nd [2nd Lieutenant?], or even a Lieutenant was in charge of the Circa. Chiefs of the sub-sections were either Lieutenants (Sublocotenent), or Segest Majors (Plutomier Major). The total personnel, in numbers, cannot be eslimuted, since besides the office personnel, militia men, on duty on the streets, supervised by the city-sub-sector militia who were in charge, taking care of traffic, etc., should be included; and I do not know how many of these existed.
- " Interesting is the fact that in the same city-sector Militia where the Office for the Control of Foreigners existed, there was an MSS office. (There was always one Office for the Control of Foreigners in each city-sector Militia). There was, of course, no inacription on the door, but I was told that this MSS (sub-) office was there, by a member of the Militia itself. This was a man whom I used to bribe ('Un. ga*) by giving him, from time to time, 100 Lei. Every Office for the Control of Foreigners had a so-called 'Cercetari pe teren' (ground investigations) section. This section was in charge of collecting all kinds of information, especially when e person was applying for an exit visa from the RFR.

He is 26 or 27 years old, green eyes, blond hair, 172 cm. tall. He comes from the Transylvania region. He is a good man, and is approachable with money. He is married.

ton Corben, Cargeant of the Militia; position: in charge of the investigations for the (Miles for the Control of Foreigners of the Circa Militie, #50 Calea Serban Voda. He is 22 years old, black hair, black eyes, married.

(fnu) Barsan, Captain in the Militia; position: Chief of the Circulatie (Tmaffic Control) Section of the Circa Militie located on (Theorem 20 Cosbuc Boulerd. He is 29 or 30 years old, medium height, blond hair, blue eyes, red face.

(fnu) Radu, Major in the Militia; position:CommandantAdjunct CMOB (II-nd in Command of the CMOB), aged 36, 172 cm. tell. blond hair, dark grren eyes. He comes from the completal, is married, and usually wears civilian clothes.

Militia personnel are usually well-mannered with foreigners. There have been cases of people being tortured or beaten by the Militia, however.

7. "His Ministry. This Ministry is located, as stated above, in the former Air Ministry on N. Belcescu Bouleverd, near the former Singer Sewing Machine Store. The Lik has a khaki uniform, the same as that of the Militia, except for the ribbon around the cap, which is blue for the MSS and red for the Militia or MAI. I think that the Fire-brigades are dependent upon the MSS. On duty (at a fire), the Fire-brigade personnel have the same uniformy as members of the RPR Armed Forces. They wear helmets, and are armed in the same way as soldiers of the RPR are armed.

- near the Republicei Cinema (formerly Scala), occupying the ex-Ciclop garage, on N. Balcescu Boulevard

The 3rd Blue Municipality Building, at the corner of Rahovei and Sf. Aposteli streets, opposite the Lycoum'Mihail Eminescu', was changed into an MSS temporary detention prison (for cases under investigation).

The 2nd Black Municipality Building, at the corner of Sf. Vineri Orthodox Church on Calarasi Street, is <u>nowadays a Judecat</u>oria de Pace - Raion T. Vla-

8. "Issuance of new ID Cards to Foreigners: During October 1953, the Office for the Control of Foreigners (of the city sub-sectors Militia), began to withdraw the old Adeverinta and replace it with a new Carnet de Identitate Pentru Cetateni Straini (Identification Card for Foreign Citizens). My memory of the details of the new card is poor. It measures about 10 by 7 cm.; the cover sheet is red-brown cardboard inscribed with gold letters as follows: Carnet De Identitate Pentru Cetateni Straini. All inside pages, approximately 10 to 15, were green, and had a filigree / water-mark? Jall over them - the PMR inscription. We presume this means that PMR was the water-mark which ran all over the page. On the first page, inside the ID card, was "MAI-DCCS; in black printed letters, then the picture of the holder (new size, having a blank right corner for the affixing of the pressed stamp), his name and surname, address and all personal data. All the remaining pages were divided into two parts, and waste used for vises / text reads: "the affixing of visas" /, when permitted. Visas were issued with special authorization, following writtem application, and allowed one to go out of the Bucharest region, / text reads: "to go out the Bucharest region outskirts" /. The last page contained cetain regulations governing the use of the card.

With the issue of the new ID cards for foreigners, the following taxation fees were applied:

One's passport remains in possession of the Office for the Control of Foreign-

- Lei 150 for all foreigners who were not in the field of labor, and for 'comercianti' (private business men).
- Lei 50 for all foreigners who were in the field of labor



A Directia Militiei exists in any raion which supervises three main sub-sections, called Circa de Militie, for Traffic Control, Control of Foreigners, end Guard and Order. There was only one Office for the Control of Foreigners (which had a 3ecurity Office with it), but the Circa de Militie P.O. existed throughout the City Sectors, their number depending upon the number of streets supervised. Each Guard and Order Militia had the following sections: supply, traffic control, P.O., economic, personnel, judiciary.
