Functions: General matters of the state budget; working out and compiling the ministry's budget; supervising the management of budgetary funds; cooperation in financial measures; maintaining liaison with the Supreme Accounting Office and the Ministry of Finance; handing down opinions in financial and budgetary matters; cooperating with the Commission for Industry and Trade in setting up the Slovak budget; travel expenses, moving expenses, separation pay, remuneration for temporarily assigned employees, and compensation for such things as daily travel expenses, etc.

Functions: Trade cooperatives; setting up on new commercial cooperatives or sales outlets; mergers of commercial cooperatives and the transfer of their establishments; reactivation of commercial cooperatives and their sales outlets which were closed during the German occupation; participation in decisions assigning confiscated property to commercial cooperatives, and providing loans and guarantees to them, supervision of the Federation of General Cooperatives; cooperation with Department I in assigning licenses to commercial cooperatives.

Functions: Commercial law associations; temporary and final authorizations to establish joint-stock companies; approval of the charters of joint-stock companies as well as changes in them, such as increasing or diminishing the number of shares or the capital involved; merging of joint-stock companies, or the admittance into such mergers of foreign companies carrying on commercial activities on Czechoslovak territory; granting permission for the incorporation of limited companies into the commercial register, and increases in their basic capital; permitting other changes in partnership deeds, such as changes in the object of undertaking of firms or companies, lowering their share capital, and other changes which fall under the jurisdiction of the ministry.

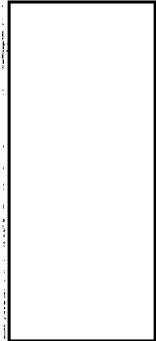

**Organization:** The internal structure is like that of the USO (Ustredni Svaz Obchodu, Central Union of Commerce). The council cooperates with the Ministry of Internal Trade, but is subordinate to the Ministry of the Interior.

**Functions:** The National Council performs mediation and advisory services for its members in all matters of a general commercial nature, small-business law, and tax questions, as well as in all questions concerned with a controlled economy.

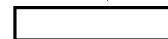

Department I deals with basic questions of economic policy, economic planning, and internal administration of the chamber.

Department II deals with the following specific matters:

Commercial and industrial policy, (industrial and foreign-trade sections); small-business law; taxation and finance; transportation; general legal questions; social policy; planned economy and price policy; vocational training section.

Department III is an institute for promoting small business. In addition to internal administration, its functions cover the following: office for promoting small business, office for special promotion activities, and a section for counseling and research.

The chamber's jurisdiction is unchanged since the original law on chambers of commerce, according to which the following districts are served by the Opava Chamber of Commerce and Small Business: Bilovec, Bruntal, Jesenik, Frystat, Krnov, Opava-Urban, Opava-Rural, and Cesky Tesin. After World War I, Hlucin was added to these areas.

The basic activity of the Chamber of Commerce, established by the Chamber of Commerce Law of 1868, has been extended and enlarged by subsequent laws and regulations. The over-all administration of the chamber and the subdivision of it into individual departments and sections have been arranged according to actual needs, present economic conditions, and contemporary assignments.

The president of the chamber and two presidium members are now appointed by the Ministry of Internal Trade, from representatives of parties of the National Front, of commercial small-business and industrial circles, of the Central Trade-Union Council, of the United Federation of Czech Farmers, and of the people's local administration.

The internal organization of the chamber is divided into three departments.

Provincial Institute for Small-Business Promotion, in Brno

The purpose of this institution is to raise the level of commercial enterprises from the points of view of specialized education and industrial shop counseling, through loans of machine shops and tools, expert evaluations, tests of products and research activities, supervising master's examinations, expert, operational, commercial, and small-business law counseling, care and support of Moravian home-industry production, etc.

Its area of jurisdiction is Moravia, while Silesia is under the Institute for Small-Business Promotion in Opava. The Machinery Procurement Cooperative in Brno, which is part of the Institute, is an executive agency for procuring cheap loans for equipment.

In matters of promoting home-industry production, the institute works in close cooperation with the branch of the Central Office of People's Artistic Production in Brno.

The Federation is an obligatory organization of all tourist enterprises (hotels, inns, lodging enterprises, spas, sanatoriums, and sporting centers). It concerns itself with the economic organization of tourist travel in Bohemia and Moravia, submits reports and proposals which deal with the economic organization of such trade, and is entrusted with the organization of local and regional groups promoting tourism.

The club was founded in 1888 by Vojta Naprstek. It has over 370 branches in all cities and large towns of Bohemia, Moravia, and Silesia, with a total membership of over 50,000. The club, by cultivating and supporting all forms of tourism, works toward the social and cultural improvement and recreation of the people, establishes tourist huts, shelters, trails, and hostels, maintains memorials, marks trails, etc. It publishes its own periodical.
