ORGANIZATION OF FORMER MINISTRY OF MEDICAL INDUSTRY USSR

[Comment: This report presents information on the Ministry of Medical Industry USSR extracted from newspapers, periodicals, and books published January 1946-September 1955 in the Soviet Union. The information covers the history, organization, and personnel of the former ministry.]

Numbers in parentheses refer to appended sources.]

I. HISTORY AND FUNCTIONS

A. Official Establishment

The Ministry of Medical Industry USSR existed from 14 June 1946 to 1 March 1948. The law which established it stated that it was to be "formed on a basis of enterprises of the chemicopharmaceutical industry, the medical instrument industry, and the prosthetics industry of the Ministry of Health USSR, the union-republic ministries of health, and the union-republic ministries of social security." Enterprises and organizations were transferred to it "according to a list confirmed by the Council of Ministers USSR."(1)

B. Functions

The Ministry of Medical Industry was mentioned in the Bol'shaya Sovetskaya Entsiklopediya (1948):

"The production of drugs, medical apparatus, instruments, articles of sanitation and hygiene, and articles for the care of the sick was, until 1946, under the jurisdiction of the Ministry of Health USSR. In 1946 the medical instrument industry and the chemicopharmaceutical industry of the Ministry of Health were transferred to the jurisdiction of the newly instituted Ministry of Medical Industry USSR. Some of the medicaments and medical instruments are also manufactured by order of the Ministry of Health at enterprises of other industries."(2)

The Bol'shaya Sovetskaya Entsiklopediya, Second Edition (1954), defines "medical industry" as follows:

"Medical industry is the industry which prepares drugs, medical and veterinary instruments, apparatus, and equipment for medical and prophylactic institutions of health organs and for filling the needs of the public. Medical industry includes the following branches of production: chemico-pharmaceutical, pharmaceutical (galenical), antibiotic, medical instruments, medical equipment, optical-mechanical, medical glassware, dental materials, prosthetics, vaccines and sera, medical visual aids, and medicinal plant and technical raw materials.

"...Enterprises of the basic branches of the medical industry are united under the Main Administration of the Medical Industry (Glavmedprom), Ministry of Health USSR. Industrial enterprises for the output of medical articles in the Ukraine are united under Glavmedprom, Ministry of Health Ukrainian SSR. The main pharmaceutical administrations of union-republic ministries of health have their own industrial enterprises and production laboratories which, besides packaging and preparing tablets and ampules of prepared drugs, also manufacture drugs from local varieties of raw materials."

II. ORGANIZATION

B. Subdivisions

An article in Meditinskaya Promyshlennost' SSSR for August 1948 (11) described the formation of the new [March 1948] Main Administration of the Medical Industry (Glavmedprom), Ministry of Health USSR, and listed the subdivisions of the former Ministry of the Medical Industry USSR which went into the new main administration. The article also listed subdivisions of the former ministry which were abolished as a result of the change. According to information in the article, the following nine main administrations were subdivisions of the Ministry of Medical Industry USSR:

1. Main Administration of Supply and Sales (Glavsnabsbyt)

Head: V. B. Shteyn.(10)

This main administration was abolished with the dissolution of the Ministry of Medical Industry USSR. Its sales function was taken over by the Main Pharmaceutical Administration, Ministry of Health USSR, and its supply function was taken over by the Main Supply Administration, Ministry of Health USSR.(11)

Advertisements in Meditinskiy Rabotnik (The Medical Worker) gave the address of Glavsnabsbyt, Ministry of the Medical Industry USSR as 12 Krivokolenny Pereulok, Moscow,

2. Main Administration for the Procurement of Medicinal, Technical, and Plant Raw Materials (Glavlektekhprom)

One Verbenko was reported as the "former head" of Glavlektekhprom, Ministry of the Medical Industry USSR.(10) Glavlektekhprom retained the rights of an independent main administration when the Ministry of Medical Industry was abolished, and was subordinated directly to a Deputy Minister of Health USSR.(11)

In 1947, Glavlektekhprom had offices in Moscow, the Ukraine, Voronezh, Kirgiz, the Crimea, Krasnodar, and Belorussia.(12)

3. Main Administration of the Chemicopharmaceutical Industry (Glavkhimfarmprom)

Head: B. M. Polikarpov.(10)

In an article in Meditinskiy Rabotnik, Polikarpov mentioned two outstanding plants which were under this main administration in 1947 -- the Moscow Chemicopharmaceutical Plant imeni Karpov, and the Moscow Alkaloid Plant. In discussing achievements of 1947 and plans for 1948, Polikarpov mentioned a number of products made in plants under Glavkhimfarmprom: codeine, bismuth nitrate, sulfamide drugs, atabrine, miarsenol, iron carbonate with sugar, pyramidon, dicain, tripaflavin, glucose, sulfathiazol, streptocide, plasmocide, luminal, methyl caffeine, sulfadimezine, and phthalazol.(13)

4. Main Administration of the Galenical Industry (Glavgalenprom)

Head: M. N. Kagan.(10)

In an article in Meditinskiy Rabotnik, Kagan mentioned two outstanding plants under his main administration -- the Kursk Pharmaceutical Plant, and the Gor'kiy Pharmaceutical Plant. Some products of plants under his main administration: avdonizide, zinc ointments and pastes, salicylate, borozinc, ichthiolzinc, and chloroform.(13)

5. Main Drug Administration (Glavlekpreparatprom)

Head: V. P. Labzin.(10)

"Glavlekpreparatprom" appears in its expanded form in two ways: "Glavnoye upravleniye [promyshlennosti] gotovykh lekarstvennykh form" (11) and "Glavnoye upravleniye [promyshlennosti] gotovykh lekarstvennykh preparatov."(13)

6. Main Administration of the Medical Instrument Industry (Glavmedinstruprom)

Head: A. P. Fedchenko.(10) Chief engineer: Dorogov.(14)

In an article in Medit'sinskiy Rabotnik, Fedchenko mentioned several plants subordinate to his main administration: the Leningrad Order of Lenin "Krasnogvardeyets" Medical Instruments Plant, the Gor'kiy Medical Instruments Plant imeni Lenin, the Suksun Optical-Mechanical Plant, the Moscow "Tekhnolog" Experimental Plant, and the Mozhaysk Medical Instruments Plant. He also mentioned some products of the plants subordinate to his main administration: "Rekord" syringes, mouthpieces (nakonechniki), drills, sterilizers, optical lenses, dental drills, tonometers, micromanometers, surgical cystoscopes, double-surfaced mirrors, forceps, instruments for stamping, chroming, and electropolishing, colposcopes (kal'poskopy), shafir [Shaeffer?] apparatus, colorimeters, dermatomes, and retractors.(13)

7. Main Administration for the Production of Medical Equipment (Glavmedoborudprom)

As of May 1947, this main administration was headed by Neverov (10), and in January 1948, by Lavrenev.(15) [His name was spelled Lavrenov in Medit'sinskiy Rabotnik, February 1948.] The chief engineer in January 1948 was A. N. Ivanenko.(13)

In an article in Medit'sinskiy Rabotnik, Lavrenev mentioned several plants subordinate to his main administration: the Doschatoye Medical Equipment Plant, the Kiev Medical Instrument Plant, and the [Kiev] "Rentok" Plant. He also mentioned some articles produced by plants subordinate to his main administration: electrocardiographs, ultrahigh-frequency generators, special beds, centrifuges, and respirators.(13)

8. Main Administration for the Production of Medical Glass and Packaging (Glavmedsteklotaroprom)

Head: V. M. Tarasov.(10) Chief engineer: Korotkov.(17)

In an article in Medit'sinskiy Rabotnik, Tarasov mentioned the following plants subordinate to his main administration: the Berezhicheskoye Glassware Plant, the Klin Glassware Plant, the Solnechnogorsk Plant, and the Yaykovskiy Sand Pits. He also mentioned some items produced by plants subordinate to his main administration: syringe cylinders, 25-liter flasks, melangeurs, and infant stomach probes.(13)

According to Medit'sinskiy Rabotnik, there were ten glassware plants under Glavmedsteklotaroprom.(18)

9. Main Administration of the Penicillin Industry [Glavpenitsillinprom?]

One Komanov [who may have been connected with this main administration] gave a report to the Collegium of the Ministry of the Medical Industry USSR in May 1947 concerning the progress made in organizing the Main Administration of the Penicillin Industry. (10)

The following nine administrations and divisions of the Ministry of the Medical Industry USSR were reported (11) as abolished with the dissolution of that ministry in 1948:

10. Main Administration of Capital Construction (GlavUKS)

No information concerning the functions of this division is available.

Two more subdivisions of the Ministry of the Medical Industry USSR were mentioned in other sources. [Comment: The fact that these two were not listed in the article (11) dealing with the dissolution of the ministry may indicate that they did not exist when the ministry was being dissolved, or that they existed under an administration. The Planning Division, however, seems to have been directly subordinate to the ministry.] The two subdivisions were the following:

19. Planning Division (21)

Sometimes referred to as the Planning and Economics Division. (22)

Head: Nikolay Nikitich Kas'yanov. Deputy head: N. M. Ivanov. (10)

20. Engineering (tekhnicheskij) Division (12)

Frayshtat was head of this division as of June 1947 (12); he was deputy head in January 1948. (15)

21. Soyuzmedpromstroy

An all-union construction trust of the medical industry, also mentioned as being subordinate to the Ministry of the Medical Industry USSR. (11)

Under this trust were: Construction Office No 1 (14) and Moscow Construction and Assembly Administration No 1. (23) One Bykov was mentioned in connection with both of the latter, and was possibly the head of the trust itself. In February 1948, one Sobolev was mentioned as head of Soyuzmedpromstroy. (18)

Main production administrations of the former Ministry of the Medical Industry were to retain their rights and were to be instituted as production administrations of Glavmedprom, Ministry of Health USSR, maintaining economic and operational control over their subordinate enterprises.

Scientific research institutions and laboratories were organically separate from plants of industry and branch administrations under the former Ministry of the Medical Industry, a situation which was to be remedied under Glavmedprom, Ministry of Health USSR, where scientific research institutes and laboratories were placed under the immediate subordination of particular production administrations of the medical industry. C. Plants and Institutes of the Medical Industry

The following is a list of plants and institutes believed to have been subordinate to the Ministry of the Medical Industry USSR while that ministry existed, compiled from references in periodicals published during the period June 1946 to March 1948. While the list is not to be considered complete, a large part of the references were in connection with the awarding of monthly "socialist competition" production prizes or honorary titles, therefore it can be assumed that the most important or the most productive plants of the period are included in the list.

D. Official Abolition

The official abolition of the Ministry of the Medical Industry USSR occurred by ukase of the Presidium of the Supreme Soviet USSR dated 1 March 1948. Its abolition was announced the following year, in March 1949, in a law confirming ukases of the Presidium of the Supreme Soviet concerning the formation, combination, or liquidation of individual ministries of the USSR. Among the ukases confirmed was one dated 1 March 1948, "On the Liquidation of the Ministry of the Medical Industry." (39) The original ukase was not found in issues of Vedomosti Verkhovnogo Soveta SSSR for 1948.

III. SUBSEQUENT HISTORY OF THE MEDICAL INDUSTRY

A. March 1948-April 1951

During this period, there was a Main Administration of the Medical Industry (Glavmedprom), Ministry of Health USSR, headed by P. F. Ostapchuk, Deputy Minister of Health USSR. (11) The Main Administration for the Procurement of Medicinal, Technical, and Plant Raw Materials (Glavlektekhprom) also "retained the rights of an independent main administration" when the Ministry of the Medical Industry was abolished, and was directly subordinated to a Deputy Minister of Health USSR. (11) According to information in the article in Meditsinskaya Promyshlennost' SSSR on the dissolution of the Ministry of the Medical Industry (11), the following were to be subdivisions of the newly-formed Glavmedprom, Ministry of Health USSR:

1. Administration of the Chemicopharmaceutical Industry (Khimfarmprom)

This administration was reported (11) as uniting plants of three main administrations of the former Ministry of the Medical Industry USSR: Glavkhimfarmprom, Glavlekpreparatprom, and Glavgalenprom. (11) However, another source (30) indicated that Glavgalenprom (head: M. N. Kagan) itself became [perhaps temporarily] an independent administration, and one Kagan was mentioned as head of Galenprom, Ministry of Health USSR. (30)

2. Administration for the Production of Medical Instruments and Medical Equipment

Head, 1949: Fedchenko. (40)

This administration was to unite plants of the former Glavmedinstrumentprom and Glavmedoborudprom of the defunct Ministry of the Medical Industry USSR. (11)

[Comment: Another source (30), also published after the dissolution of the Ministry of the Medical Industry USSR, uses the abbreviation Medoborudprom, which presumably means "Administration for the Production of Medical Equipment." This would seem to indicate that the former Glavmedoborudprom maintained, at least temporarily, an independent existence as Medoborudprom.]

3. Administration for the Production of Medical Glassware

This administration was to unite plants of the former Glavmedsteklotaroprom, Ministry of the Medical Industry USSR."

Note: The abbreviation "Medsteklotaroprom" was used in connection with "branch administrations" under the Ministry of Health USSR. (30)

4. Administration of Antibiotic Production

Head: Engr A. P. Grishakova. (41)

This administration was to have been formed on the basis of the former Glavpenitsillinprom, Ministry of the Medical Industry USSR. (11) In an article in Meditsinskiy Rabotnik (30), reference is made to a "Penitsillinprom" as one of the "branch administrations" under the Ministry of Health USSR.
