longed absences this summer, Dipl. Ing. Rudolf Mueller (SED), technical director of VEB Carl Zeiss, Jema, made most of the decisions normally falling within the jurisdiction of Director Schrade. However, no official announcement was made appointing him acting chief or giving him a similar title. In spite of this lack of official announcement, it was generally assumed by the plant personnel that Mueller, referred to in the plant as "RuMue", would eventually be appointed deputy chief or second in command. Many of the top men in Zeiss Jens have reservations about Mueller's overall technical qualifications, but felt that such a cheice would not be too bad for the plant because he has three points in his favor: (a) he is an old member of the Zeiss plant family; (b) he is a member of the SED, yet well liked by most of his subordinates; and (c) he has the ability to make decisions (not necessarily always correct emes) and does not precreatinate as Schrade was in the habit of doing for the past year.

2. In early October 1955, a new official by the name of Weiss or Weitz (fnu-) appeared at the plant, apparently under SED auspices, and, although no efficial announcement has been made, it is understood that he will become deputy chief of VEB Carl Zeiss, as soon as he has familiarized himself with the firm. Nothing is known as yet concerning Weiss professional or personal background, although some officials who have come in contact with this person state that he either came from Dresden or had previous experience with a main administration in East Berlin.
