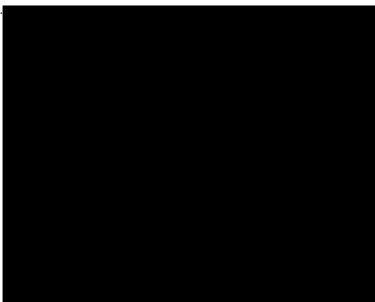
SUBJECT: Minutes of 30 August 1956 Committee Meeting

b. Suggestion No. 1833 - Referred to the Logistics Office as recommended at a previous Committee meeting and answered by a memorandum from Logistics which recommended disapproval. The Committee agreed that the specific proposals of suggestion #1833 were not adoptable. Disapproved for award.

c. Suggestion No. 2045 - The Committee agreed that steps were to be taken to allow the suggester and the Office of Logistics evaluator to get together and discuss this suggestion.

5. The Executive Secretary briefed the Committee on the handling of suggestions concerning the Credit Union suggestions through the Suggestion Awards Program.

6. The Committee agreed that suggestions in which the suggester requests reconsideration should be presented to the Committee for action as to whether

1. The case should be reopened.
2. If reopened, where it should be sent for evaluation.

The Committee further agreed that the 3rd party method evaluation by a disinterested party could be used when suggester and office of primary interest cannot reconcile their differences of opinion, however, they felt that referral to a 3rd party should be a matter for the Committee to decide.
