Car.), the following publications, per his request of 5 July: "China Oil Production Prospects," June 1977; xeroxed pages on Peoples Republic of China and Taiwan from the National Intelligence Factbook, January 1978; "China: International Trade, 1976-77," November 1977; "China: Economic Indicators," October 1977; "A Study of Climatological Research as it Pertains to Intelligence Problems," August 1974; "Potential Implications of Trends in World Population, Food Production, and Climate," August 1974; PRC Atlas and a wall chart on "Chinese Communist Party Organizations," September 1977. These publications are for Mr. Carbaugh's reading in advance of a speech the Senator is preparing to make.
