Record was defined as all information relative to a personality which may involve more than one unique format.

a. Specific sources used to gather information should be identified (e.g., names of newspapers, journals, etc.).

13. Discussed requirement within the U. S. Intelligence Community for information relative to specific Soviet Personalities. Studies, if made, should make a distinction between current or past requirements. A study of these requirements should indicate what kind of information is required and by whom.

14. On several occasions representatives of DIA have asked whether or not participating agencies couldn't receive a print-out of all changes made to the files. Today two possible plans were discussed:

a. Users could ask the same set of questions every day with respect to specific Soviet personalities to determine if any new information has been added.

b. An updated index of significant Soviet Personalities could be kept in the system and then whenever a record is added or changed on one of these individuals a report would automatically be distributed to the agency concerned. This is similar to the "Hot List" of stolen cars distributed by the police.

(1) State Department has a "Look-Out List" for key personalities as well as a Soviet Watch List.

(2) [redacted] CIA indicated that they had some experience in attempting to do this manually. He will prepare a paper for the next meeting indicating some of the problems they encountered.

15. Source

a. [redacted] DIA distributed a description of the "Construction of Intelligence Report Numbers" (See Handout # 10).

b. Problem of how to indicate source in each record remains as a major problem for future discussions.
