Policy on Use of the SCIPS Data Base

- 1. Attached is the second revision of the draft policy statement on the use of the SCIPS data base, prepared pursuant to discussion at the 17 October CODIB meeting. The change suggested by the Navy and NSA representatives is in para. 4.
 - 2. The Director of Naval Intelligence also submitted the following comment:

"Although paragraph 4 refers specifically to the subparagraphs of DCID 1/7 which states, 'IT (Controlled Dissemination material) SHALL NOT BE DISSEMINATED TO CONTRACTORS,' paragraph 6 states that access by contractor personnel shall be governed by USIB-D-39.5/19. USIB-D-39.5/19 contains a provision which permits Controlled Dissemination to be released to contractors, if special permission has Dissemination to be released to contractors, if special permission has been obtained in writing from the originator. This inconsistency should be resolved, or holders of DCID 1/7 should be notified that it has been amended, if such is indeed the case."

- 3. I do not feel that there is an inconsistency here. The basic principle is that Controlled Dissem material should not go to contractors, but exceptions may be warranted. The SCIP state base must be tightly controlled, but parts of it may be most valuable in Community systems design work. Para. 7 of DCID 1/7 allows for a case for exception to the general rules to be put to the originator(s); USIB-D-39.5/19 elaborates on contractor release procedures, including provision for exceptions.
- 4. Action: Please notify the Secretary of your agency or departmental approval of or comment on this draft
 USIB formal approval will be sought.

SCIPS Data Base

- 1. The information in the SCIPS Data Base was collected under the aegis and for the use of USIB (CODIB-D-82/18, 1 Aug 62). The data base consists of information obtained from some fifty organizational components of the various USIB Departments and Agencies on the processing of substantive intelligence information. The data base is in the form of exhibits, survey forms, punched cards, magnetic tape files, and machine listings. The machined portion is statistical information on the kinds and quantities of people, equipment, files, processes, documents, and document movement in the intelligence community.

 Access by USIB member agencies for own use
- 2. The data was collected as an essential part of the study effort; it was converted to machine language to facilitate its analysis. Furnishing member agencies with useful data about themselves and the Community of which they are a part is an implicit if not expressed part of the SCIPS survey. The

by-products of such an undertaking were recognized as having considerable potential significance for the participating agencies.

3. Accordingly, access to the data base by a USIB member agency will be granted for its own use.

Security requirements

- 4. The machined portion of the data base has an ever-all-classification of Special-Intellegence/Controlled-Dissem/No Foreign-Dissem, and will be handled in accordance with Annex E of DCID 6/3: Special Intelligence Regulations and DCID 1/7: Controls for Dissemination and Use of Intelligence and Intelligence Information (New Series) 21 Feb 62, see especially para.

- 5. Parts of the data under machine control are of low classification, and can be handled accordingly.

Access by contractor personnel

6. Access to the data base by contractor personnel shall be governed by USIB-D-39.5/19, 26 Aug 63, Final-USIB-Approved: USIB Policy on Release of Intelligence to Contractors.

Holding of master files, computer programs and documentation

7. Master SCIPS files will be held by CIA, which will provide service therefrom.

Reproduction of files, computer programs and documentation

8. Duplicates of SCIPS files, programs, and documentation will, on request, be made available to USIB agencies. The number of duplicate files or portions thereof will be kept to a minimum commensurate with the needs of the various agencies to conduct extensive research in the data.
