SUBJECT : Guidance on Implementation
of Executive Order 11652

1. The purpose of this notice is to furnish guidance in the classification and marking of [redacted] documents and material in accordance with the requirements of Executive Order 11652.

2. The [redacted] Control System continues in effect without reissuance or reapproval.

3. The DCI exempts from the General Declassification Schedule of Executive Order 11652, all levels of classified information within the purview of the [redacted] Control System.

4. In accordance with the above and in compliance with Executive Order 11652:

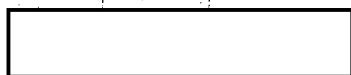
(e) Document receipts do not require the new markings unless the title of the document is shown and it contains substantive [redacted] information.
