Thank you for your letter of 28 January regarding [redacted]

[redacted] wrote to us on 30 December 1963 and enclosed a resume of his experience for our consideration. He is obviously a man of considerable ability as an executive and manager who would be an asset in a position commensurate with his substantial background. However, our recruitment activity is conducted primarily at the junior officer level and we do not often have openings in senior positions. [redacted] qualifications were carefully reviewed in light of our current openings but we did not locate any immediate opportunity commensurate with his stature and experience. He was advised of this result in a letter dated 20 January, a copy of which is enclosed for your information.

We have retained [redacted] file for reconsideration in the event an appropriate vacancy should develop. However, our present forecast of requirements based on a reduced personnel ceiling indicates that such a development is unlikely for some time.

Your letter on [redacted] behalf is appreciated and you may be sure that he will receive every consideration if a suitable position should become available.

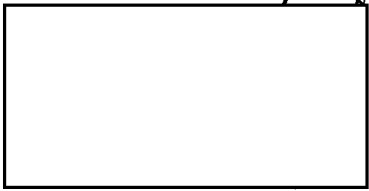
