

As you will note there were none made by the Agency for FY 65. For your information, the Congress approved legislation, PL 85-934 in 1958 that permitted the head of each agency to, among other things, make grants to nonprofit institutions of higher education for the support of basic scientific research. The head of each agency "shall make an annual report...(setting forth) the number of grants.... the dollar amount of such grants, and the institutions in which title to equipment was vested...." The report is referred to the House Committee on Government Operations and the Senate Committee on Science and Astronautics.
