- 1. SG 161/20 is the 1966 edition of the annual MATO Standing Group intelligence estimate. The preparation of the US Position Paper is a routine exercise requiring no new estimative judgments. DIA produces first drafts for those sections for which the US is responsible. These DIA drafts are reviewed and amended by the Board of Metional Estimates and USIB representatives, and are then submitted to USIB, not for approval, but for "acceptance" as consistent with the relevant MIEs and releasable to MATO. The draft: as accepted by USIB is submitted to the JCS for approval.
- 2. Reference A is the draft text as amended by the Board of Butional Estimates and USIB representatives. In Reference B the Board recommends USIB "acceptance" of it, by telephone to the UBIB Secretariat.
