On September 8, 1964, a draft copy of the National ELINT Plan was forwarded to your agency and your reply of October 30, 1964 suggested certain modifications. In addition, other actions were taken to improve the managerial arrangements for the Department of Defense ELINT operations. Your recommendations and the Department of Defense actions were noted by the ELINT Advisory Group, on which you provide membership and the Plan was revised by this group to reflect these recommendations and actions.

I have already approved the execution of those portions of the National ELINT Plan involving DOD resources; however, no promulgation has been made to date of this document. I would therefore appreciate receiving your concurrence to the attached document in order that we may issue this as a coordinated publication. This publication, when distributed, will serve as the basis for the effective management of the total National ELINT effort.
