**MEMORANDUM FOR: Director of Central Intelligence**

**SUBJECT : UAR National Policy Paper**

1. This memorandum contains a recommendation for approval by the Director in paragraph 4; a letter for his signature is attached.

2. The UAR National Policy Paper (Basic attachment) has been completed by an interagency working group in which a senior DD/I officer participated, and is now ready for review and approval at the departmental level. Salient points of the paper are described in attachment A.

3. The Acting Chairman of the Board of National Estimates, and the Special Assistant to the DDS&T have reviewed and approved this paper.  concerning policy problems affecting the discharge of its responsibilities. The Acting Chairman, Board of National Estimates, further states that a SNIE on the UAR is not called for at this time, since the subject was covered in SNIE 36.1-64, dated 6 May 1964.
