REFERRAL TO NSC NOT REQUIRED

Dear Don:

I have your gracious letter of 10 June 1965 requesting the services of [redacted] for the next year in connection with activities of the Office of Science and Technology. As you know, he is presently Assistant Director in charge of our Office of [redacted] in which we are concentrating most of our computer applications in CIA, and I have discussed this request carefully with my Deputy, Dr. Wheelon. Our general reaction to such a request would be positive, as we believe it important both to support intragovernment enterprises and to give our own people a broader exposure to Government operations.

A special problem arises in [redacted] case. He has an able deputy, [redacted], who could normally shoulder his responsibilities for this period. Unfortunately, [redacted] is leaving CIA and the Government this summer for family reasons, and this is a major loss. There is really no one else in that office who can step up to take [redacted] place. Were we to send [redacted] off on a year's assignment, we would create a very serious lack of leadership in the over-all CIA program for application of Automatic Data Processing techniques to the intelligence problem. I believe this to be one of our most pressing problems, and trust that you will understand my reluctance to move backward on it.

His specific duties would include:

- Through the mechanism of the Federal Council for Science and Technology, act for OST to provide leadership, coordination, and evaluation of the total national R&D program in information transfer technology.
- Act for OST in relations with the library community, including spearheading a study of the U. S. medical library system.
- Assist Mr. William T. Knox, of OST, in our national information systems planning.

This office has assumed the primary responsibility for mounting a broad attack on the problems of information systems supporting science and technology. Mr. Knox, my senior assistant in this area, has a very high regard for Mr. [redacted] s ability. It appears to me that [redacted] training, experience, and interests


