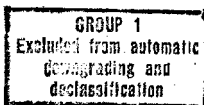
**SUBJECT:** Annual Report for the President's Foreign  
Intelligence Advisory Board

1. Last year the President's Foreign Intelligence Advisory Board changed its request for periodic reports from CIA (as well as DIA) to an annual, rather than a semi-annual, basis. This report is now to be submitted each year for the year ending 30 June. Currently we are required to prepare one for the year ending 30 June 1965.

2. Attached is the outline used last year, which remains unchanged. The components responsible for preparing each section are indicated. Where two or more components share responsibility, please coordinate informally so as to avoid duplication. The outline is not meant to be restrictive; that is, all components should feel free to expand on it if they believe the outline does not cover adequately all pertinent information. Also, the General Counsel and Inspector General should contribute if they feel they can report developments in their areas which would be of value to the Board. |||

3. This year's report should not, of course, repeat basic information contained in last year's version, except as necessary to explain developments of the past year. Last year's version - being the first comprehensive annual one - contained, under a number of headings, explanations of why or how certain activities have come into being. What we want to do for Fiscal Year 1965 is to carry the report forward from the Fiscal Year 1964 base.

4. Without in any way prejudging the size of the final report, it is suggested as a guide that each element tailor its submission to about the

5. As the Deputy to the DCI for National Intelligence Programs Evaluation has been charged with relations with the PFIAB, I am asking him to deal directly with components of the Agency concerned with the preparation of the annual report. Accordingly, please submit drafts in duplicate, double-space, by 7 September 1965 to Mr. Parrott  who will be prepared to assist you or your officers with any aspect of this assignment. It would be appreciated if each addressee would give him the name of the officer directly responsible for the submission.

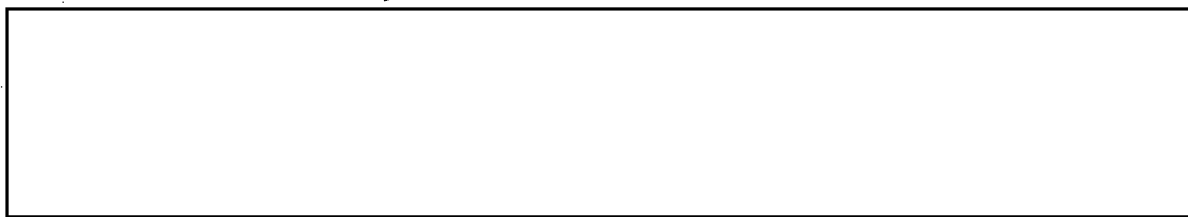

**SUBJECT :** Requests from the President's Foreign

1. Attached is a copy of a memorandum from the President's Foreign Intelligence Advisory Board listing five subjects on which the Taylor/Murphy Panel wishes information.

2. Items 1, 3 and 4 are, of course, within DD/P's responsibility. Item 2 would probably best be done by ONE, perhaps in coordination with SAVA. Item 5 would seem to call for a joint DD/P-  
[redacted] and DD/S&T response.

3. No deadline was indicated by the Panel; however, in view of the extreme interest shown in China and related areas by Clark Clifford, ostensibly on behalf of the President, it seems clear that we should give this a high priority.

4. Please send your responses to this office for consolidation with two copies to go forward and one for our files. If any questions develop, we will undertake to get them clarified with the Board.


