SUBJECT: Gaps and Deficiencies Briefings for PFIAB

- 1. Confirming the discussion at the Staff Meeting this morning, the following is my understanding of the arrangements for briefing PFIAB Panels on the gaps and deficiencies identified by the Secretaries of State and Defense in intelligence coverage of subjects of particular interest to them.


