Dear General Carroll:

As you know the United States Intelligence Board recently directed me to set up some permanent machinery to support its Committee on Documentation in carrying out a number of studies through ad hoc working groups.

In discussions with Dr. [redacted] I suggested that we consider a table of organization of four professionals and two clericals, with DIA providing two professionals and CIA providing two professionals as well as the clericals.

On that basis I would appreciate it if DIA would nominate two documentalists for full-time detail on a non-reimbursable basis. We can then proceed with discussions with them to make certain that those nominated by you and by CIA in fact add up to a balanced team. In my opinion the individuals could be either military or civilian with equivalent general level of experience in the GS-13 to GS-15 range.

It would be particularly useful if one of the DIA participants in the SCIPS effort were available as this would provide valuable continuity not otherwise obtainable.
