You may rest assured that we welcome your proposal to assure a more complete exchange of intelligence reports and studies prepared under contract for CIA and for the several components of the Department of Defense. 2. The list of studies and reports done under contract for the Department of Defense since 1 July 1963, to which you refer, will be gratefully received. CIA's contracts for external research have been and continue to be listed with External Research Staff in the Department of State. I trust that their classified inventory of Government sponsored research will satisfy your needs for information on CIA-produced studies.

3. As for studies and reports coming in now and henceforth, our Office of Central Reference will see to it that the Defense Intelligence Agency is on the standard distribution list for each one. Mr. [Redacted] Assistant Director for Central Reference, will be our action officer for the exchange, and he will get in touch with whomsoever you designate to make sure that the exchange proceeds as it should.

**SUBJECT:** Reports Produced by Contractors, RCS: DD-DIA(AR)G2

**TO:** Director, Central Intelligence Agency

1. In the past there has been a limited exchange of contractor-produced intelligence reports, studies and findings between components of the Department of Defense and the Central Intelligence Agency; however, it has largely been restricted to specific areas of interests. Since the funds expended to secure such reports are Government funds, I believe that there should be a more complete exchange of the results of such production effort within the intelligence community.
2. I am taking steps to have contractor-produced reports, studies and findings of Department of Defense components, together with listings of such reports produced since 1 July 1963, furnished to you through this agency.
3. I propose, therefore, a mutual and future exchange of contractor-produced reports between the Central Intelligence Agency and the Defense Intelligence Agency. I hope that this proposal meets with your approval and that this beneficial exchange of information can occur at an early date.
