1. Pursuant to the reference memorandum as approved by you, the semi-annual review of the clearance status of USIB committee members has been conducted by each of the Committee Chairmen at my request. MEMORANDUM FOR CHAIRMAN, USIB

1. Pursuant to your memorandum of 2 March, the status of clearances of USIB committee members relative to the performance of their duties has been reviewed with each of the committee chairmen and with the advice and assistance of [redacted] Acting BSO and TSO/CIA. This review indicated that most of the committee members had the requisite clearances, but that in certain cases the clearance status of some members was not completely up to date.

2. Based on this review, arrangements have been made to assure that all members of USIB committees have all the clearances necessary to perform their mission, as determined by the committee chairman in each case. The general level of clearances of each of the committees is shown in the attached listing.

3. Wherever [redacted] clearance is indicated, the actual clearances are based upon the particular projects pertinent to the committee's mission. In addition to the clearances shown, a number of the committees also have appropriate Restricted Data clearances as required.

4. Subject to your approval of the clearance status as indicated, a procedure will be established for at least semi-annual review with the committee chairmen.

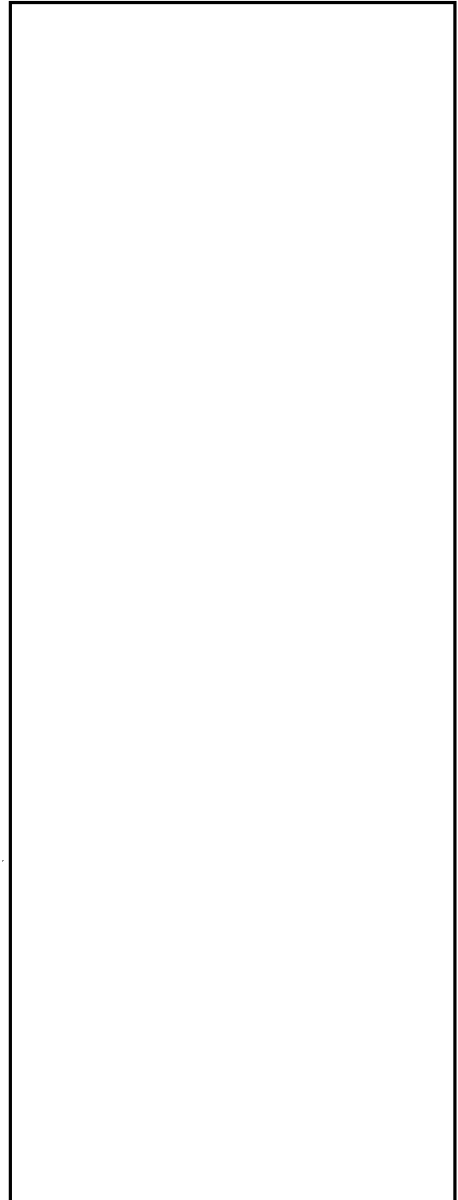
