- 1. This memorandum is for your information only and responds to reference.
- 2. At the present time the Top Secret Code Nord Centrol Committee is conducting a thorough analysis of document controls within the Agency and to date has dealt with the problems involved in the fields of Top Secret and SI. The reports on RD. document controls will be considered on 17 and 24 April and 1 May 1964. All participants will be requested to submit written reports and recommendations. The Committee will then analyze all problems and recommendations and one of the problems to be considered will be the unauthorized reproduction of Tup Secret and Code Ford documents. All aspects of this serious problem will be surveyed to ascertain what will be the best means to prevent or control the "bootleg" reproductions. It may be that controls applicable to Top Secret material would be inapplicable to Code word material.

MEMORANDUM

SUBJECT: Proposal to Limit the Reproduction of Sensitive

- I. At a meeting of the TS/Codeword Control Committee on Triday, 20 March, reported on his survey of Agency TS controls. Among other things, he reported that about twenty-five or thirty percent of our employees admitted that they reproduce TS documents. A conversation followed in which it was pointed out that a periodic inventory of TS documents is meaningless as long as these documents can be easily reproduced with impunity. Such an inventory might indicate where the original document was physically located but, as procedures stand now, it certainly could not tell how many thermofax copies were floating around inside (or outside) our buildings.
- 2. Most individuals at the meeting concurred that TS documents are reproduced with nothing more sinister in mind than 'making a working copy". However, the Agency's tolerance of reproducing TS documents by thermofax makes it relatively easy for anyone (having access to TS documents) to reproduce them and take them out of the building for sinister purposes.
